CORRECTION TO REPLY COMMENTS OF THE INDEPENDENT MARKET MONITOR FOR PJM

On June 7, 2013, Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor for PJM ("Market Monitor"), submitted comments in reply to the comments filed by GenOn Power Midwest, LP and Commission Trial Staff in the above captioned proceeding.

In those comments, the Market Monitor stated (at 5):

Retail electric customers pay the bill for RMR services, and no retail customer or party directly responsible for protecting retail customers is party to the GenOn RMR Settlement.

This statement is incorrect. Three parties to the GenOn Power Midwest, LP Settlement Agreement represent some of the retail customers who bear ultimate responsibility for payment of the RMR charges that will be established in this proceeding: Duquesne Industrial Intervenors, PJM Industrial Customer Coalition, West Penn Power Industrial Intervenors.

The Market Monitor respectfully requests that the Commission include this Correction to Reply Comments in this proceeding.

PJM Interconnection, L.L.C. is a FERC approved Regional Transmission Organization. Capitalized terms used herein and not otherwise defined have the meaning used in the PJM Open Access Transmission Tariff ("OATT").
