**MOTION FOR EXTENSION OF THE
INDEPENDENT MARKET MONITOR FOR PJM**

Pursuant to Rules 212 and 2008 of the Commission’s Rules and Regulations,¹ Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor (“Market Monitor”) for PJM Interconnection, L.L.C. (“PJM”), respectfully requests an extension of time, until December 1, 2025, for the submission of comments in response to the request for approval of a transaction under Section 203 of the Federal Power Act. The current deadline for the submission of comments is October 21, 2025.²

In addition, the Market Monitor requests the deadline for comment on this motion be reduced to two days in order to provide sufficient notice to all parties on whether the extension is granted.

The Market Monitor requests an extension of time to submit comments because the filing in this docket raises issues that require more time for adequate consideration than afforded by the current deadline for comments. The time between the filing on September 30, 2025, and the current October 21, 2025, deadline is insufficient for gathering information and for doing the analysis required. Analysis of the transaction is further complicated

because the transaction involves a power station, the Carroll County Energy Center, that is the subject of this filing and two other filings under Section 203 in Docket Nos. EC25-123 and EC25-151. The deadline for comments in Docket No. EC25-151 is December 1, 2025.³ Setting the deadline for comments for pending reviews of transactions involving the same power station on the same date is reasonable and would facilitate an orderly process for review. A common deadline would allow the Commission to resolve issues raised in the these cases based on a more complete and accurate record.

Accordingly, the Market Monitor respectfully requests that the Commission grant this motion.
