Section II.C.1 of Attachment M-Appendix of the PJM Open Access Transmission Tariff (OATT) provides:

The Market Monitoring Unit shall maintain, post on its website and provide to the Office of the Interconnection prior to each RPM Auction (updated, as necessary, on at least a quarterly basis), a list of Existing Generation Capacity Resources located in the PJM Region that are subject to the “must-offer” obligation set forth in Section 6.6 of Attachment DD.

Accordingly, Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor for PJM, has posted on its website ([www.monitoringanalytics.com](http://www.monitoringanalytics.com)) the attached list of PJM Existing Generation Capacity Resources, as reflected in the eRPM system, which, as of the date hereof, are subject to the must offer obligation for the 2016/2017, 2017/2018, and 2018/2019 Delivery Years.

This list does not include Demand Resources, Energy Efficiency Resources, Planned Generation Capacity Resources, or external Generation Capacity Resources that did not qualify for exception to the Capacity Import Limit. This list does not account for RPM commitments, FRR commitments, or exports or such other alternative means by which the requirement set forth in Section 6.6 of Attachment DD to the OATT may be satisfied.
