

## Appendix – Errata/Addendum

### Section 9: Ancillary Services

**Change:** Add the following paragraph and table to page 292.

Table 9-25 shows new black start NERC critical infrastructure protection (CIP) capital costs being recovered by black start units in PJM. These units were located in multiple zones, including ComEd, DEOK, DLCO, JCPL, Met-Ed, PENELEC and Pepco. The CIP costs are recoverable through Schedule 6A of the tariff, and include both physical security and cyber security investments in order to protect black start units deemed critical. CIP costs included the cost of equipment necessary to restrict access to physical sites, as well as the cost of software upgrades necessary to protect cyber assets and monitor unit operations.
