MOTION FOR LEAVE TO ANSWER OF THE INDEPENDENT MARKET MONITOR FOR PJM

Pursuant to Rule 212 of the Commission's Rules and Regulations,¹ Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor for PJM ("Market Monitor"), moves for leave to answer, if it becomes necessary, the motion filed by Talen Energy Marketing, LLC ("Talen"), on December 5, 2016, opposing the Market Monitor's motion to intervene in this proceeding, which was filed July 11, 2016.

Because the Market Monitor remains actively engaged in settlement discussions with Talen and believes that a settlement resolving its concerns can be achieved, it would not be productive to submit an answer at this time. Talen has indicated to the Market Monitor that it is fine with an extension of the time to answer the motion in light of the circumstances.

The next scheduled settlement conference in this proceeding is Tuesday, January 10, 2017. The Market Monitor proposes to file its answer, if it becomes necessary, on Friday, January 13, 2017. No ruling on this motion is sought unless and until an answer is filed.

The Commission's Rules of Practice and Procedure, 18 CFR § 385.213(a)(2), do not permit answers to answers or protests unless otherwise ordered by the decisional authority. The Commission has made exceptions, however, where an answer clarifies the issues or
