Summary of FTR Obligation and Option Activity: June through December 2008

During the 2008 to 2009 planning period, the Annual FTR Auction cleared 19,836 MW (4.9 percent) out of 402,418 MW of FTR option buy bids and cleared 68 MW (1.1 percent) out of 6,263 MW of FTR option sell offers. The monthly FTR auctions through December 31, 2008 cleared 11,750 MW (1.8 percent) out of 651,005 MW of FTR option buy bids and cleared 24,628 MW (18.6 percent) out of 132,310 MW of FTR option sell offers.
